PERSONAL INJURY

MATRIMONIAL DISPUTES

In addition, valuations of shares and businesses and tax calculations are often needed in divorce cases to assist the parties and the court.

This also included a projected loss of value in capital/goodwill the individual would have realised, up to the point of normal expected retirement age.

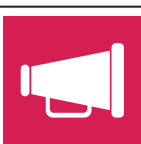
